M I N U T E S REGULAR MEETING OF THE BOARD OF DIRECTORS February 16, 2022 6:00 p.m.

A. CALL TO ORDER & ROLL CALL

This regular meeting of the Board of Directors of the De Luz Community Services District was held at the DLCSD office, 41606 Date Street, Suite 205, Murrieta, CA on February 16, 2022. C. SHERIFF:

Deputy Perez delivered the Sheriff's Report and provided an update on recent law enforcement activity. He reported that the Sheriff's Department has been collaborating with the Temecula Police Department to remove the homeless camps on Rancho California Road. He advised anyone who notices suspicious vehicles or transients to call the authorities. The written report has been sent to the district.

G. SANDIA CREEK / VIA VAQUERO (FEMA) RECONSTRUCTION PROJECT

District Engineer Hunt provided an update on the status of both projects. He reviewed and discussed the work schedules for both projects in detail with the Board.

I. BUENA VISTA RECONSTRUCTION PROJECT

District Engineer Hunt reported that the final review of the environmental permits is still in process and that he expects permits to be issued early Spring. There are no further details at this time.

President Roberts paused Item J

K. TRAFFIC SAFETY

Traffic Engineer Libring reported that the CMS sign is being rotated each week to different streets to encourage drivers to exercise caution and watch their speeds. He also reported that staff is evaluating requests for an all way stop at Los Gatos Road and Carancho Road and an all way stop at La Cruz and Sandia Creek Drive. He advised the Board that the evaluation for speed limits is still in process and request has been received to restrict turns on Buenos Campos Road during peak hours.

J. ORDINANCE NO. 22-01: SPEED LIMITS

Introduction and First Reading of Ordinance No. 22-01: Establishing Speed Limits on Carancho Road and Via Vaquero Road.

Motion was made by Bowman, seconded by D'Alessandri, that Ordinance No. 22-01 be introduced by title only; that further reading by waived and that Ordinance No. 22-01 be passed to second reading.

L. ROAD MAINTENANCE/FIELD CREW REPROT

Wyatt reported that field crew is continuing to clear the tree growth along the shoulders of roadways and reported on the ongoing activities throughout the district.

M. COMMITTEE REPORTS

ENGINEERING COMMITTEE REPORT

Director Roberts reported that the Engineering Committee met on February 8, 2022. Roberts explained that the information was presented by staff who brought the committee up to date with the most current information which was presented previously in this meeting. The committee is continuing to evaluate various projects for the 2022 Roadway Rehabilitation program and will advise the board at a future meeting.

FINANCE COMMITTEE REPORT

Director D'Alessandri reported that the Finance Committee met on February 15, 2022. He informed the Board that the financial audit had been delayed due to COVID-19 issues. The committee also examined the expense of IT equipment for board and committee meetings. He said that IT communication has greatly improved which allows the public to continue to engage virtually.

H. <u>CONSIDERATION OF CHANGE ORDER #1 TO SANDIA CREEK/VIA VAQUERO</u> RECONSTRUCTION AGREEMENT-MURRIETA CONSTRUCTION

General Manager Emmons reported that pending the asphalt for the additional work the opening of Sandia Creek Drive and Via Vaquero Road would be February 28th, 2022.

Motion was made by D'Alessandri, seconded by Bowman to approve the change order for additional pavement repairs and slurry seal at the Sandia Creek and Via Vaquero project.

P. LEGAL COUNSEL MATTERS

General Counsel Simmons reported that Cal Recycle adopted regulations to implement Senate Bill 1383 in order to achieve organic waste reduction goals established in Health and Safety Code and title 14 of California Code of Regulations. Simmons explained that the district was denied the low population waiver that exempts the district from organic waste collection requirements. Simmons informed the Board that we now need to submit a Notification of Intent to Comply.
