D. PROJECT PROGRESS:

General Manager Holmes reported the following:

- Peter's Paving, Inc. has completed work on "El Viento Seco slope repair" repair and "FEMA DCSD-03, Repairs to Los Gatos Road".
- American Asphalt South has completed the crack and seal portion of the "2011 Crack and Slurry Seal Project". Roads are being striped and should be completed by the end of November.
- Malek Construction has completed work on "FEMA DCSD-09, Erosion Repair to Sandia Creek Drive".

- The District field maintenance crews are prioritizing culvert cleaning and drainage channel maintenance going into the wet season.

E. FUTURE PROJECTS:

GM Holmes reported that Bids will be received on October 18, 2011 for the Project "Improvements to Vuelta Grande and Vuelta Chica; Carancho Road Slump Repair; and Calle Capistrano Drainage and Roadway Improvements". Contract to low bidder be presented to the Board for award at next week's Board Meeting.

GM Holmes is reviewing all roadways and prepairing crack seal project for this winter.

GM Holmes report that a supplement to the November District Newsletter was sent by email to subscribers, posted on the community bulletin boards and copies placed in the newsletter bins for the public. The main item addressed in the supplemental newsletter is the additional bulky item drop off scheduled for Novemeber 19th to coincide with the Santa Margarita Watershed Cleanup.

Committee reviewed the revised Roadway Rehabilitation Fund Balance/Projection report that was modified to flow more like a balance sheet. Committee expressed satisfaction with the report in its current format.
