# I. 2020 ROADWAY REHABILITATION PROJECT

Engineer Hunt reported that the Slurry Seal project has been completed by American Asphalt South, Inc. He recommended that the Board accept the work as completed, direct filing of the Notice of Completion, and authorize retention release as prescribed by the Public Contracts Codes.

#### J. BUENA VISTA RECONSTRUCTION PROJECT

Engineer Hunt explained that he was asked to present the recommendation of the Engineering Committee to the Board, however; Chairman Roberts would introduce the recommendation to the Board. Roberts, on behalf of the Engineering Committee recommended that the District proceed with the Buena Vista project for the 2021-2022 Improvement project. Hunt presented the three (3) options; Option 1 – Finish the 2016/2017 work in the Primary Zone Via Vaquero, Option 2 – Zone 1, Buena Vista Road Culvert Crossing Repair, and Option 3 - New Projects spread out between all six zones. The committee recommended Option 2.

Motion was made by Adams, seconded by Johnson to approve Buena Vista Road Culvert Crossing Repair for the 2021-2022 Improvement project.

# K. TRAFFIC SAFETY

Traffic Engineer Libring reported that the CMS sign is being rotated each week to different streets to encourage drivers to exercise caution and watch their speeds. He also advised that County of Riverside installed a new guardrail along Ranch California Road. He reported that field crew is continuing to work with the Sheriff on illegal dumping and that crew is rechecking 223 drains for any weeds, silt or other accumulation

# L. COMMITTEE REPORT

#### **ENGINEERING COMMITTEE**

Director Roberts reported that the Engineering Committee met on March 9, 2021 and March 15, 2021, the committee discussed the items presented previously by the Engineer.

#### FINANCE COMMITTEE

Director D'Alessandri reported that the Finance Committee met on March 16, 2021 and discussed the February claims along with items previously discussed. He advised the Board of a session he had with Banner Banker regarding the implementation of payroll direct deposit. It will save time and be more efficient.

#### LEGISLATIVE-SB415

President Byers reported that the draft Bill, SB415 is now with the Legislative Counsel for review. The committee is now waiting on the Counsel to return the bill with the final language. She advised that there are no further updates at this time.

#### M. GENERAL MANAGER REPORT

General Manager updated the Board regarding a scheduled meeting with CalOES. He reported that for FEMA to pay on any large project expenditures, every project must be closed out in their database. He explained it will take an estimated one (1) year for FEMA to close out the Districts projects due to the COVID situation. However, because FEMA is halfway through the Districts closing process, the District can request the immediate reimbursement of 90% of the large project obligations. Finance Manager Snyder included that she is working on the request and expects to start receiving funds in approximately three (3) months.

#### N. LEGAL COUNSEL MATTERS

Simmons advised the Board that Riverside County moved into the Red Tier from Purple Tier. This means restaurants, movie theaters and museums will be able to increase indoor capacity to 25%, among other changes.

There being no further business, President Byers adjourned the meeting at 7:31p.m.
