#### E. LEGISLATION

President Roberts expressed the appreciation of the entire community and the Board of Directors to Senator Kelly Seyarto for his successful Legislation SB613 (Seyarto). This legislation is extremely beneficial to De Luz CSD in making the District exempt from the requirement of organic recycling. This legislation reinstated the rural exemption of the original law to districts such as De Luz. The Senator discussed his Bill and the process by which it was approved by the Legislature and the Governor. A plaque was presented by President Roberts for his efforts with SB 613.

The Board and Senator discussed Fuel Tax Legislation, explaining that Fuel Funds to be provided to the County of Riverside for allocation to Community Services Districts created by the County for the purpose of maintaining public roads.
