A. CALL TO ORDER AND ROLL CALL

Committee Members Raymond Johnson and Debbie Roberts were present. The meeting was held electronically by Zoom.

B. PUBLIC COMMENT:

C. MINUTES:

D. SANDIA CREEK AND VIA VAQUERO RECONSTRUCTION PROJECTS

Project Engineer Stein reported that there have been positive responses from the governmental agencies regarding the final assessment of the environmental permits. He advised that the project plans have been readied for negotiations with the contractor and expects to have permits granted by mid- July.

E. BUENA VISTA RECONSTRUCTION PROJECT

Project Engineer Stein reported that the project is out to bid and has been getting responses from contractors for the plans. The bid-opening is scheduled for July 8, 2021 and award of the contract is expected at the July Board meeting.

F. TRAFFIC ISSUES

Traffic Engineer Libring reported that the CMS sign is being rotated each week to different streets to encourage drivers to exercise caution and watch their speeds. He reported that the flashing stop sign on Rancho California Road and Avenida Del Oro has been repaired by the County of Riverside.

G. FIELD CREW REPORT




ADJOURNMENT
